In consideration of Highland Outfitters permitting the undersigned to use its hunting facilities and services, the undersigned on his behalf and on behalf of his heirs, executors, and administrators hereby absolutely and forever releases and discharges Highland Outfitters, its employees, agents, assigns, officers, directors, and independently contracted guides from all claims of any kind whatsoever, whether at law or in equity, which the undersigned has had or now has or otherwise hereafter can, shall, or may have for or by reason of personal injury, loss of income, and all loss or damage to personal property in respect of, or arising out of, said use of the hunting facilities and services including the transportation to and from the hunting facilities as well as all matters relating to the undersigned hunting with Highland Outfitters.

In further consideration the undersigned hereby authorizes Highland Outfitters to take photographs of the undersigned and any harvested animals and to use such photographs for promotional advertising of Highland Outfitters.
